

The Ultimate Kit Giveaway – Terms and Conditions

1. Sponsor and Organizer

This Giveaway is organized by Musora Media Inc., headquartered at 31265 Wheel Ave #107, Abbotsford, BC V2T 6H1 (“Musora Media”).

2. Eligibility

This Giveaway is open to individuals aged 18 years or older. Employees, contractors, affiliates, and family members of Musora Media are not eligible to participate. All entrants must comply with local laws and regulations in their jurisdiction. This Giveaway is void where prohibited by law and is subject to all applicable federal, state, provincial and local laws and regulations.

3. Agreement to Rules

By participating in this Giveaway, entrants agree to abide by these Terms and Conditions and the decisions of Musora Media, which are final and binding in all matters.

4. Giveaway Period

Entries will be accepted online starting on October 21st, 2025 at 12:00AM PST and ending on November 20th, 2025 at 11:59PM PST. All online entries must be received by no later than November 20th, 2025 at 11:59PM PST.

5. How to Enter

To participate in this Giveaway: Submit your email address via www.Drumeo.com/win and answer the skill-testing question provided at the time of entry. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Musora Media. There is no purchase necessary. All entries are the property of Musora Media.

6. Limit on Entries

Limit of one entry per person using one email address. Additional entries beyond this limit will be disqualified.

7. Grand Prize
